Recommendation of Names to be Added

<u>Summary</u>

- 4. A working group member seeks estimates from manufacturers about producing necessary plates.
- 5. We consider results of consultation as soon as possible so that we can have a definitive proposal for Town Council in September 2017

RESTORATION OF CHELTENHAM WAR MEMORIAL Condition survey and conservation options appraisal

NEW INSCRIPTIONS

The original eligibility criteria, detailed within the Council minutes of 1919 and as designated by CWGC at the time, was as follows:

- Men fallen whilst engaged in active service during WW1 or
- Who lost their life from injuries sustained in active service up until **31**st August **1921**

In the case of Tewkesbury the deadlines were: WWI: 31 December 1925³

WWII: 28 February 1955⁴
Born or resided within the Borough of Cheltenham

After consultation

project team propose to expand the criteria to include

• women and those who were born or resided within the current town boundary, unless their names are featured elsewhere.

Advice received from the War Memorials Trust indicated that the following evidence must be in place:

- A copy of a military record [some military records were lost in the London Records Office fire during WWII].
- A copy of an official birth, death or marriage certificate
- Confirmation that the individual is not commemorated on another local war memorial
- Evidence that the local community has been notified (e.g. local newspapers articles, public notices etc..) we sometimes find that there are other members of the community who have discovered a missing name(s) and it is both cheaper and less damaging to the memorial if missing names are added at the same time.

Initially, it was thought that over 100 names needed to be added but further research Using these criteria has reduced the number to less than twenty.

Before I comment on specific cases listed in the attached papers I would like to expand upon the official eligibility criteria for War Casualty Status (War Office/IWGC/CWGC) and the local criteria given to me by Cheltenham Council.

# Official Eligibility Criteria.

1. Official War Casualty Status. Criteria set by the Government (War Office) as contained in the Royal Charter of May 1917 (as amended) for the establishment of the Imperial War Graves Commission were:

a. <u>Category One</u>. Commonwealth men and women who were in military service at the time of their death. These personnel automatically qualify for official commemoration provided they died within the qualifying dates as follows:

# First World War - 4th August 1914 to 31st August 1921

# Second World War - 3rd September 1939 to 31st December 1947

The location of their death and the cause of death are immaterial to their qualification. They could have been killed in action, died of wounds, died of illness or by accident, died due to suicide or homicide or suffered judicial execution. CWGC treats all casualties equally and all must be commemorated under the terms of their Royal Charter.

b. <u>Category Two</u>. Personnel who had been discharged from or retired from the military before their deaths during the same qualifying periods of an injury or illness caused by or exacerbated by their service during the same qualifying period. <u>These cases qualify only if it is PROVEN to the authorities'</u> <u>satisfaction that death was service attributable.</u>

c. Category Three. War grave status and CWGC commemoration is restricted to personnel serving in a Commonwealth armed force but members of certain civilian organisations may qualify if they meet various additional criteria.

Examples of qualifying civilian organisations are:

First World War – Mercantile Marine, British Red Cross Society, YMCA and Voluntary Aid Detachments.

Second World War – Merchant Navy, Home Guard, War Correspondents and BOAC.
